# Message from the Trust's new Chief Executive NIK Patten

Dear Member,

I am delighted to be able to introduce this edition of Your Trust News, my first as the Trust's new Chief Executive.

I am now in my fourth week at the Trust and I must say I am already very impressed with the excellent care we are providing to our patients.

I have spent more than 20 years working in the NHS and, although my previous job was in a large teaching hospital, my roots are very firmly in district general hospitals. I am really pleased to have joined a Trust that looks after two top performing ones and also a fantastic community hospital like Stamford and our aim is to continually make all three hospitals even better for patients, staff and our local communities.

Partnership working is, of course, key to our continued future



success and I would like to reiterate the importance the Trust places on having a well-informed and active membership – your views, opinions and challenges are really important to us. With this in mind I would like to invite you to comment on our proposals for the future of Stamford Hospital. It is a very exciting time and, together with Lincolnshire Primary Care Trust and the Welland Group of GPs, we are exploring a new joint management arrangement for the hospital that will help

to secure local services at the hospital for the local community. You will find a consultation document attached to this newsletter so you can provide your views.

Things have also been progressing quickly during the last few weeks with some of our other major initiatives. The Strategic Health Authority's approval of the Greater Peterborough Health Investment Plan (GPHIP) is a significant milestone and although there remains a lot to do to achieve approvals from the Department of Health and the Treasury, we are hopeful we will receive these by the Spring and see construction begin soon after.

We are also progressing the contracts with our commissioning primary care trust partners. We are working hard together to ensure we are ready to meet the government initiative to improve elective surgery waiting times for patients. This will mean that all patients will receive their treatment within 18 weeks of referral by December 2008. This should also allow us to make some much needed investment in some areas if we are able to treat the additional patients.

At the time of going to press, the investigation into the orthopaedic waiting

list is continuing and I am hopeful that the findings of the report will be available to share with our membership in the next issue of Your Trust News. We are confident that the results of the investigation will lead to a much improved service for all of our patients.

Finally, let me say that I feel privileged to have been asked to join the Trust and I very much look forward to working with you, as a member, in the very near future.

The new revised parking charges for visitors are as follows:



# Your Priorities Our Response

In the last members' newsletter we told you we would be addressing issues raised from the survey carried out in the August edition of 'Your Trust News', in future newsletters. In this edition we are covering the priority of the need to keep services local at Stamford Hospital. The Trust is running a formal 12 week consultation exercise that will end on 22 June 2007. Attached to this newsletter you will find a detachable document

including a feedback form. The results of the consultation feedback will be collated by an independent organisation. The results will be assessed by the Trust together with the Welland group of GPs and the Lincolnshire Primary Care Trust, and shared with the public via the local media, Hospital Trust's Public Board meetings, 'Your Trust News' and the Trust's website. We expect to be able to do this by August 2007.











Peterborough & Stamford Hospitals NHS Foundation Trust currently manages Stamford Hospital. The Hospitals Trust, Lincolnshire Primary Care Trust and the Welland Group of GPs are considering a new approach to managing Stamford Hospital and want to gain your views as part of this process.

### What are we proposing?

- That Stamford Hospital is managed jointly by Peterborough and Stamford Hospitals NHS Foundation Trust and local GPs.
- That the management of the hospital would be advised by a Board of Governors with representatives from the local community and partner organisations.
- That Stamford Hospital is focused on providing the local care and convenient treatment needed by the surrounding community.

### Why are we considering this?

- This will better enable Stamford Hospital to become a genuine Community Hospital, providing traditional hospital and community services conveniently located on one healthcare campus.
- There is a changing approach to health care delivery with a focus on moving care and treatment closer to the patient. This is about providing care at the right level and place which may mean some services moving out of a traditional hospital setting.
- A failure to take action may lead to a reduction in the services available at Stamford Hospital as services and the associated income move elsewhere.
- The local area has an aging population with a need for quality care more locally delivered.
- There is an increasing number of people living with long-term conditions such as bronchitis and diabetes and the hospital would be an ideal location to develop services locally for these patients.
- There is a desire for convenient access to quality treatments.
- Stamford Hospital needs to respond to these changes if it is to continue to thrive as a centre for health care, social care and treatment for Stamford and the surrounding area.

### How will this help?

We believe, with the Hospitals Trust and local GPs working more closely together and supported by the advice of local governors, Stamford Hospital will:

- Have a better understanding of the community's needs.
- Be better able to develop care services that meet those needs.
- Be more likely to continue to thrive as a centre for the local care and treatment required by the community.

### What will it not do?

As is the case now, Stamford Hospital will not be able to offer services that would be clinically unsafe, such as maternity deliveries and complex or major surgery.

### What happens next?

- The questionnaire overleaf forms part of a formal 12 week consultation exercise that will run until 22 June 2007.
- Public meetings will also take place on 18 April (Stamford Hospital, 2.30pm); 1 May (Stamford Hospital, 2pm) and 14 May (Stamford Hospital, 2.30pm). Please call 01733 875424 to confirm attendance.
- The results of the consultation feedback (form overleaf) will be collated by an independent organisation. The results will be assessed by the two trusts and the Welland group and shared with the public via the local media, the Hospitals Trust's public board meetings and the Hospitals Trust's website. We expect to be able to do this by August 2007.
- If the local community agrees that the proposal for changing the management of Stamford Hospital should be pursued the results of this consultation exercise will be an important consideration in any agreements entered into between Peterborough and Stamford Hospitals NHS Foundation Trust and the local GPs.
